All cycles and / or equipment on loan MUST be returned to CERA Cycloan after use without damage and specified by the date shown below.

Any person loaning a cycle and equipment must provide the documentation listed below before a cycle and / or equipment loan can be agreed.

These documents will be left securely with CERA Cycloan until the cycle and equipment is returned in the same condition it was loaned out.

On return / receipt of the cycle and / or equipment back to CERA Cycloan a check of the cycle will be conducted. **Any damage or loss of cycle is the full responsibility of the person loaning the cycle and must be paid in full by the person who has loaned the cycle.**

Once the cycle has been safely returned to us and checks have been completed the cycle will be signed off all retained documentation will be returned to the person in question. (please allow 15 mins for the sign off process on return)

- Passport
- Drivers Licence
- Proof of address (current utility Bill or bank statement)
